Who can apply?

Law Students who are pursuing the Law Five years or Law Three years' degree course or who have passed one years before applying for internship program.

<u>Skills required</u>: Efficiency in written Communication (English/Hindi), Legal writing, Basic legal knowledge, Computer Operation in Word/Excel/PPT.

Students can apply online/offline for Internship Program-2025 through Lokbandhu Rajnarayana Law College official website i.e. www.lbrlawcollege.org

Application should be submitted with scanned copy of Identity Card issued from College/University & passport size photograph of the applicant along with recommendation letter issued by principal/HOD of Law Department. In case desired documents are not attached, then application will not be considered. & a Statement of Purpose for doing Internship written by the Student/Applicant himself/herself in max. 70 words.

Students will be shortlisted and selected on the basis of their expression of interest through the Statement of Purpose submitted with the application and draw of lots, if more than required applications are received. The shortlisted students will be informed about the same.
